#### **ICE SCHEDULING –JEFF TIDBALL**

Jeff has the SWM ice confirmed and the contract has to be signed for the coming season. Some changes have been made for the coming season on rentals. Scheduled rentals if they are going to be cancelled they need to be submitted in writing 2 weeks in advance to avoid ice charges. If ice is cancelled in a window shorter than 2 weeks and they are able to rent it out no charges will incur.

Ice charges in Glencoe are going to be until dec 31 \$140 per hour including HST.

Jan 1 to the remainder of the season in Glencoe will be \$144 per hour plus HST

Glencoe ice will be in Sept 29 and removed Mar 30.
